# Limited Warranty for Residential Coastal Collection Doors General Information

#### **ONE-YEAR DOOR WARRANTY**

Fimbel Architectural Door Specialties manufactures the Amarr Coastal Collection sections using Vinyl Composite Technology (VCT). Fimbel Architectural Door Specialties Carriage House Doors made using our Vinyl Composite Technology (VCT) are guaranteed to be free of commercial defects in materials and workmanship for a period of one year following shipment to the original purchaser, proof of purchase is required. Fimbel Architectural Door Specialties will repair or replace at its option any material which proves to be defective under normal use provided it has been left in its natural white condition or has been painted in strict accordance with Fimbel Architectural Door Specialties' painting instructions.

The warranty does not apply to any damage or deterioration caused by abuse or misuse, failure to provide reasonable and necessary maintenance, improper installation or handling of garage door or electric garage door opener, fire, hail, flood, wind or any other acts of God, failure of paint applied after manufacture and distribution, alterations and/or additions to door, or environmental conditions, including, but not limited to: (1) areas subject to fallout or exposure to corrosive chemicals, fumes, ash, cement dust, animal waste, or foreign substances, (2) areas subject to water runoff from lead, copper, or galvanic metal flashing, and (3) areas subject to excessive abrasion such as exposure to wind borne sand and other harsh particles.

This warranty is for installations of complete garage doors for single-family residential, residential condominium or similar residential multi-family housing. It does not apply to commercial, industrial, or non-residential uses.

Any charges for freight, removal, installation, or labor shall be the responsibility of the original purchaser. Material shall be returned freight prepaid to Whitehouse, New Jersey during the term of said guarantee period. Material adjudged defective by Fimbel Architectural Door Specialties will be repaired or replaced at Fimbel Architectural Door Specialties' option and expense and will be returned freight prepaid. Materials not properly finished, not used in a normal manner, or materials that have been abused or damaged will be repaired or replaced at the customer's expense, and shipped freight collect.

#### LIMITED LIFETIME DOOR SECTION EXTENDED WARRANTY

Fimbel Architectural Door Specialties further warrants the PVC Composite sections of the Amarr Coastal Collection for as long as you own them not to crack, split or peel, providing the sections have been left natural white, or painted with heat reflective vinyl-safe paint in strict accordance with Fimbel Architectural Door Specialties' painting instructions. Please refer to our Painting Instructions on the reverse side or at www.fimbelads.com for detailed instructions.

### **Limited Warranty for Amarr Hardware for Amarr Coastal Collection**

Amarr Garage Doors warrants to the original purchaser that if any part or hardware (excluding exterior decorative hardware) supplied by Amarr for Amarr Coastal Collection Garage Doors is defective in material or workmanship, we will repair or replace it for (3) three-years from the date of purchase. The three-year hardware warranty applies to standard lift and low headroom applications only (not to high-lift or vertical lift) and only when utilizing 15", 20" or 32" radius track.

## **Cleaning Instructions for Amarr Coastal Collection Sections**

In order to ensure years of trouble-free performance, the face and edges of the Coastal Collection sections are UV-resistant and may be left in their natural white color. For general cleaning, use warm water and a dishwashing liquid soap. DO NOT use cleaners containing acid or solvents like MEK, acetone or Toulon. For more stubborn situations, Soft Scrub, Clorox Cleanup or Clorox Outdoors can be used. Do NOT use Simple Green all-purpose cleaner. Be sure to scrub with the grain of the surface. For the most stubborn of stains, lightly sand with 200 to 220 grit paper, and always sand with the grain. The door surfaced can be wiped with denatured alcohol to remove any soap, cleaner residue or dust.

## **Painting Instructions for Amarr Coastal Collection Sections**

Use of any paint finish other than the two recommended options mentioned below is done at the customer's risk. Damage resulting from failure to follow these recommended painting instructions will void the warranty.

Clean sections by following cleaning instructions above. For painted sections, use one of the two options: (1) Sherwin Williams VINYLSAFE Super Paint formulation is the only recommended heat reflective paint for the Coastal Collection sections. This heat reflective paint system is specifically formulated to bond to vinyl surfaces and reflect the sun's rays off the vinyl surface, cooling and protecting the surface. This Sherwin Williams VINYLSAFE Super Paint system offers a wide range of standard and custom color choices. Do NOT use Sherwin Williams Non-Vinyl Safe Super Paint as a vinyl door could be potentially damaged due to excessive heat stress and will void your warranty. Do NOT use Sherwin Williams VINYLSAFE Duration or Resilience paint as they may cause mechanical problems due to not fully curing and are not acceptable to use on Vinyl doors. (2) The Coastal Collection sections are available with a professionally applied, factory-finished paint color. These paints are high performance, heat-reflective vinyl paints that have a 15-year warranty from the paint manufacturer.

Staining of the Amarr Coastal Collection sections is not recommended. Any field staining voids the section warranty.

Failure to follow the recommended painting instructions may lead to premature failure of the sections and voids the section warranty.
